“GUESS THE MEASURE!”

FULL TERMS AND CONDITIONS

PolyWorks Europa S.A.S., 100% owned subsidiary of InnovMetric Software Inc., with registered offices at 62, Rue de la Chaussée D'Antin - 75009 Paris – France (hereafter the “Promoter” or “Organizer”) is organizing this Promotion, called “GUESS THE MEASURE!”.

The Promotion is open to legal residents of Italy, France, Spain, and Portugal, aged 18 years old or over.

Employees of the Organizer and their immediate families, as well as their agents, business partners, and distributors, or anyone professionally associated with this Promotion shall not be eligible to enter. Similarly, employees, collaborators, or consultants in any capacity of the companies 42 Racing SA and Racing One GmbH as well as all racing teams engaged in the International GT Open championship shall not be eligible to take part therein.

Participation in this Promotion is free of charge and no purchase is necessary. Internet access is required in order to enter.

Any person entering into or participating in this Promotion is deemed to have accepted and to be bound by these Terms and Conditions.

1. Promotional period

The promotion is open from 00:01 (UTC +2 Time) on 5th June 2024 until 23:59 (UTC +2 Time) on 1st October 2024, inclusively (also called “promotional period”).

The promotional period is divided into the following **sub-periods** of participation:

- CHALLENGE #1: from 00:01 on 05/06/2024 to 23:59 on 21/07/2024
- CHALLENGE #2: from 00:01 on 28/08/2024 to 23:59 on 14/09/2024
- CHALLENGE #3: from 00:01 on 17/09/2024 to 23:59 on 01/10/2024

The reference time for participation in the “GUESS THE MEASURE!” competition is **UTC +2 / Central European Summer Time (CEST)**, which corresponds to the time zone of Paris and Rome.

2. Entry and participation

To participate in the competition during the promotional period outlined in point 1, individuals must visit the website www.guessthemeasure.com to complete the registration process. They must provide all mandatory information in the designated form, agree to the Terms and Conditions, and optionally consent to data processing for marketing purposes.

Upon registration, an image depicting a specific mechanical component (whose technical name will be provided during the game) will be shown to the participants. Subsequently, they will have to input their estimation of the size of this mechanical component in the designated field.

The correct measures (reference measure) of the mechanical component used for this competition are solely those recorded by the Promoter and manually identified by Racing One GmbH. No objections can be raised regarding the correlation of these reference measures with those obtained through other means.

The participant who accurately guesses the measurement of the mechanical component or provides the closest estimation to the actual measurement in the shortest time will be declared the winner.

In the event of a tie, the participant who has provided a correct answer (i.e., guessed the correct measurement or provided the closest estimation in the shortest time) will be awarded the prize.

Entry limitation:

Each individual is permitted only one entry per CHALLENGE or sub-period. Entries with the same data (e.g., email address, name, surname) will not be considered as a valid participation in the Promotion.

The Promoter reserves the right, at any time, to verify participants' identity, age, and place of residence in order to ensure the validity of their entry and participation in the Promotion. The Promoter retains the right to disqualify any participant who breaches the Terms and Conditions or tampers with the registration process.

3. Selection of the winners

At the end of each sub-period, a ranking will be compiled based on the response time.

The top-ranked participant in each sub-period (i.e., the individual who accurately guesses the size of the mechanical component or provides the closest estimation to the actual measurement in the shortest time) will be declared the winner.

The subsequent ten (10) highest-ranked participants for each sub-period shall be designated as reserves. They will only be contacted if the primary winner cannot be located or fails to meet prize eligibility requirements, or if any other reason prevents the prize from being awarded to the primary winner.

In the event of a tie, the participant who has provided a correct answer (i.e., guessed the correct measurement or provided the closest estimation in the shortest time) will be awarded the prize.

A total of three (3) winners, one (1) for each sub-period, will then be selected throughout the entire promotional period.

Each winner will be awarded one (1) VIP weekend experience in Monza during International GT Open on the 19th and 20th of October, 2024.

Prizes are non-transferable to third parties.

4. Prizes

The available prizes are as follows:

- Three (3) VIP weekends in Monza at the International GT Open championship on the 19th and 20th October, 2024.

Please note that GT Sport Organización, the organizer of the International GT Open, is not the Promoter of "GUESS THE MEASURE!". Therefore, GT Sport Organización bears no responsibility for the administration of the Promotion, the verification of winners, or the allocation of prizes.

Each VIP weekend consists of:

- One (1) VIP PASS for one (1) person to attend the International GT Open races in Monza (Italy) on the 19th and 20th of October, 2024, along with VIP Hospitality treatment during the individual's stay at the circuit.
- Roundtrip airfare for one (1) person to Milan Malpensa, Milan Linate, or Bergamo Orio al Serio. Note that if the winner of the VIP weekend resides within a 300-kilometer radius of Monza (Italy), the Promoter reserves the right, at its sole discretion, to provide ground transport instead of air transport, without any obligation to make an exchange or pay compensation for the difference in premium value.
- Two (2) nights in a 4-star hotel.
- Transfer from the hotel to the circuit.
- One (1) gourmet dinner on Saturday evening, October 19th, 2024.

The average value of a single VIP weekend is €1.300.

The winner is solely responsible for any expenses not explicitly mentioned in the prize description above. These expenses may include, but are not limited to:

- land transport not specified above;
- parking fees;
- meals and extra charges;
- tips, duties, or taxes;
- surcharges;
- airport fees;

5. Winner notifications and prize delivery

Within five (5) business days after the end of each sub-period of participation, the winner will receive an email notification to the address provided during registration. They must respond within three (3) calendar days, providing:

- Their personal information (i.e., name, surname, address, email address);
- A copy of a valid identity document (front and back).

It is imperative that the information provided during the registration is accurate and genuine, as falsifying information or using a pseudonym is prohibited. Failure to match the provided information during entry with that of a valid identity document will result in the prize not being awarded.

Please note that the win can only be confirmed after receipt of the required documents, which must be sent by the deadline.

A winner who fails to respond will be deemed unreachable, and the prize will be allocated to reserves in order of ranking. Reserves must adhere to the same acceptance procedure and timeframe. Note that:

Information to be provided pursuant to Article 13 of Regulation (EU) 679/2016 (the General Data Protection Regulation, GDPR).

Personal data provided voluntarily will be processed using electronic methods as well as analysis tools, and will be used for statistical analysis by **PolyWorks Europa S.A.S., 100% owned subsidiary of InnovMetric Software Inc.**, with registered offices with tax identification number TVA: FR 47812673028, with registered address at 62 rue de la Chaussée d'Antin, 75009 Paris, France (Data Controller) for completion of all stages relating to the prize competition known as "GUESS THE MEASURE!". In addition, it will be processed so as to comply with administrative regulations and other general obligations imposed by current EU decisions, and stored for the period of time established by these regulations. It is obligatory for participants to provide the data requested for the aforesaid purposes. Failing to do so will make it impossible to carry out management operations relating to the prize event and to comply with legal requirements.

Subject to their express consent, the winners' data will be published via different communication media, including on the internet, and in informational and promotional material in digital and paper form.

The data shall be processed by 42 Racing SA – Via Serafino Balestra 10, Lugano – Switzerland and Promosfera srl – Via XXV Aprile 56, Casorate Sempione (VA) - Italy. (Data Processors)

The individuals authorized for data processing are sales and marketing personnel, call center staff, and IT systems and data security personnel.

Pursuant to Articles 15 21 GDPR, by writing to the controller using their postal address or email address at privacy@innovmetric.com, participants may exercise their rights to consultation, modification, erasure and the right to be forgotten, the right to restriction of processing or to object to processing on legitimate grounds or for informational and promotional reasons, including via certain means of contact only (e.g., email, landline and mobile phone, text message, and post). If not specified, the objection will be extended to all means of contact. Should a participant revoke their consent, which may be done at any time, it is understood that this shall not prejudice the legality of processing based on consent previously given or alternative mechanisms of consent provided by law. Participants also have the right to file a complaint with the supervisory authorities to enforce their rights. - The Promoter reserves the right to verify the validity of entries and to disqualify any individual for tampering with the registration process or for submitting an entry that does not comply with the Terms and Conditions, or if an entrant engages in any unlawful or improper conduct intended to undermine the proper execution of this Promotion. The Promoter reserves its legal rights to seek damages or other compensation from such an offender.
- Unless prohibited, acceptance of a prize constitutes the winner's consent to the Promoter's use of their name, appearance, social media presence, photography, voice, hometown, city/state and/or response for promotional purposes with any support, worldwide, for no payment or consideration.

8. Submission of T&Cs

The rules are submitted via www.reglement.net, with SELARL 812 – HUISSIERS, huissiers de justice associés, 88 boulevard de la Reine, 78000 Versailles. Rules are subject to modification at any time by the Promoter, provided such amendments adhere to the specified Terms and Conditions and are announced via an online publication on the website www.guessthemasure.com. The amended rules shall take effect immediately upon online publication, and all participants shall be considered to have accepted them by registering in the Promotion, from the date the amendment becomes effective. Any participant who does not accept the modifications must discontinue their participation in the Promotion.

The Promoter and participants will exert themselves to amicably resolve any disputes arising from the interpretation or implementation of these rules. To initiate this process, any claim must be submitted in writing exclusively to the designated address, providing precise details of the claimant (name and address). Written disputes and claims will no longer be considered

after a period of two (2) months following the end of this Promotion. No other method of dispute resolution or claim submission may be taken into consideration.

In the event of an inconsistency between the provisions of the present rules and any and/or all information concerning the Promotion, the provisions of the present rules filed with the Court Bailiff shall prevail.

In the event of a final disagreement, the Paris courts shall have sole jurisdiction.

9. APPLICABLE LAW – DISPUTES

The Promotion's participants are bound by the French regulations governing games and contests. In the event of an unresolved dispute, it shall be brought before the competent courts as designated by the provisions of the French Code of Civil Procedure.
